6.) New Business

(a) Roads Superintendent-Pre-Approval Request for Portion of Gravel and Roads Maintenance (Report 2017-09-PF)

Roads Superintendent, Paul Feltz, presented his Report No. 2017-09-PF, wherein he requested early budget approval on East Shore Road and North Shore Road (Clutton to North Shore Pump House), in order to begin to lay gravel prior to the boat running in order to allow gravel to settle and pack, and be ready for laying dust suppressant on schedule for 2017.

Discussion ensued on the state of the roads in question and what would be the most efficient way to get things completed. The Treasurer stated that the last few years the Budget allocated for Roads was approximately \$90,000.00, and that it would be logical to assume that approximately the same amount would be approved for 2017. Deputy Mayor DeLellis questioned whether the assistance of additional trucks would help speed up the process and requested that the Treasurer obtain quotes from Erie Sand & Gravel per kilometer for laying gravel. Councillor Dayne Malloch suggested granting approval for North Shore Road now and wait for the quote from Erie Sand & Gravel before granting early budget approval for East Shore Road. Motion to Commence with North Shore Road.

(b) Roads Superintendent-Maintenance Plan Updates

The Roads Superintendent reiterated the plan of early start of laying gravel as per 6(a). Discussion ensued about various ways to maintain the roads, removal of ridges, shoulders, pooled water and downed trees. Councillor Moritz brought to the attention of the Roads Superintendent concern of hanging limbs over East West Road. The Roads Superintendent advised that he would take a better look at the situation and evaluate what is required for removal.

(c) CAO/Clerk-ERCA/Pelee Island Orthography/Aerial Photography (Report 2017-10-KD)

The CAO/Clerk presented her Report 2017-10-KD, wherein she outlined how ERCA's GIS mapping program benefits Municipal Staff in accessing aerial maps, property boundaries and areas in the 100 year flood plan. She stated that municipal staff uses this information for assistance in planning, property location boundaries and public information. The CAO/Clerk advised that the cost previously was either absorbed by the County, subsidized by the MNRF and/or covered by ERCA. She commented that moving forward the cost would not be covered by the County and would be left to stakeholders should there be an interest. The CAO/Clerk stated that ERCA was hoping to partner with the Township and split the cost. Discussion ensued on the necessity of continuing with this project or waiting until 2019-2020, to participate, and Council agreed to wait until the next project date to and reassess participation at that point.
