Purpose (Information/Action): Information

#### **BACKGROUND:**

Over the last several weeks, high winds and wave action have had a negative effect on West Shore Road most notably between the LCBO and the Legion.

Interim Roads Superintendent has confirmed that in several places the tar and chip was lifted out and into the roadway. The road base is still holding.

On January 7, 2020, roads staff were able to repair the larger, damaged areas with cold patch asphalt. The smaller damaged areas/potholes were addressed with gravel. The lakeside of the roads edge is affected by erosion and breaking up in places but is not considered a major event at this time.

Roads staff have dumped approximately 90 tonne of rip rap from the quarry to protect the road South of Stone House 1891 and by the Legion it address a newly evident weak spot that was encroaching close to the road. Invoice attached in the amount of \$4,331.85.

Drainage cuts have been added to help channel as much water as possible away from the road. The Roads crew are closely monitoring and proactively making repairs as soon as possible to avoid further degradation.

When West Shore Road, north of the dock is ice covered, this section of roadway connecting to East West Road is residents only access to the Township Office, the Clinic, Legion and is the emergency route to service the south end of the island.

#### **RECOMMENDATION:**

Roads Crew continue to closely monitor erosion to lake side road-bed of West Shore Road and proactively make repairs to prevent further degradation of road surface.

Township to provide notice via social media when/if road conditions have deteriorated the barriers when deemed appropriate per current road closure policies.

WHEREAS, the Municipality of Thames Centre is committed to planning for a sustainable future for its resources and environment;



#### **CORPORATION OF THE TOWNSHIP OF PELEE**

**BY-LAW NO: 2020-01** 

## "2020 INTERIM TAX LEVY" (January 13, 2020)

A by-law to provide for an interim tax levy and to provide for the payment of taxes and to provide for penalty and interest of 1.25 per cent.

WHEREAS Section 317(1) of *The Municipal Act 2001*, as amended provides that the Council of a local municipality may, before the adoption of the estimate for the year under section 290, may pass a by-law to levy amounts on the assessment of property in the local municipality rateable for local municipality purposes, a sum not to exceed that which would be produced by applying the prescribed percentage (or 50% if no percentage is otherwise prescribed) of the total 2019 taxes for municipal and school purposes levied on the property; and

**NOW THEREFORE** the Council of the Corporation of the Township of Pelee enacts as follows:

- 1. Interim tax levies are hereby imposed on the whole of the assessment for real property for all property classes according to the assessment roll for taxation in the current year, and shall be in the amount equal to fifty per cent (50%) of the final 2019 taxes on the property.
- 2. When calculating the total amount of taxes for the year 2019 under paragraph 1, if any taxes for municipal and school purposes were levied on a property for only part of 2019, an amount shall be added equal to the additional taxes that would have been levied on the property if taxes for municipal and school purposes had been levied for the entire year.
- 3. The said interim tax levy shall become due and payable in two instalments as follows: February 28<sup>th</sup>, 2020 and May 31st, 2020.
- 4. Penalties and interest shall continue to be calculated at the rate of one and one-quarter percent as provided for in By-law 2019-27.

This By-law was read a first, second, and third time in open council and passed this 13th day of January 2020.

**BY-LAW NO: 2020-02** 

#### "2020 CURRENT EXPENDITURE BORROWING BY-LAW"

(January 13, 2020)

A by-law to authorize the borrowing of money to meet current expenditures of the Council of the Township of Pelee

WHEREAS in accordance with subsection 401(1) of the Ontario Municipal Act, S.O. 2001, c.25 the Municipality may consider it necessary to borrow in the amount of \$1,100,000 to meet, until taxes are collected and other revenues are received, the current expenditures of the Municipality for the year;

AND WHEREAS pursuant to subsection 407(2) of the Act, the total borrowed pursuant to this by-law together with the total of any similar borrowings is not to exceed the limits set forth in the subsection or other relevant sections of the Act and is so required under subsection 407(2), the Municipality shall have obtained the approval of the Ontario Municipal Board;

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE TOWNSHIP OF PELEE ENACTS AS FOLLOWS:

THAT the CAO/Clerk/Treasurer is authorized on behalf of the Municipality to borrow from time to time from the Libro Credit Union (CU) a sum or sums not exceeding in the aggregate \$1,100,000 to meet, until taxes are collected, the current expenditures of the Municipality for the year pursuant to subsection 407(1) of the Act, and to execute any documents that are required in connection with the borrowing of the above sum, plus interest, at a rate to be agreed upon from time to time with the CU, in addition to any reasonable charges of the CU associated with this borrowing;

AND THAT all sums borrowed pursuant to this by-law as well as all other sums borrowed pursuant to the Act in this year and in previous years from the CU for any purpose will, with interest thereon, be a charge upon the whole of the revenues of the Municipality for the current year and for all preceding years or from any other source which may lawfully be applied for this purpose;

DATE January 13, 2020

AND THAT the CAO/Clerk/Treasurer is authorized to furnish to the CU a statement showing the nature and amount of the estimated revenues of the Municipality not yet collected and also showing the total of any amounts borrowed that have not been repaid;

AND THAT by-law 2019-03 passed on the 21st day of January 2019 is hereby rescinded.

AND THAT this by-law shall come into force and take effect on the  $1^{\rm st}$  day of January, 2020 and it short title shall be "2020 Current Expenditure Borrowing By-Law."
