- Due consideration has not been given to the use being made of the land.

All notices of appeal shall be given in writing to Janice Hensel, CAO/Clerk Clerk of the Township of Pelee at least ten (10) days prior to the first sitting of the court and shall state the grounds of appeal. The last day for filing a notice is Monday, April 9, 2021 which is ten days prior to the first sitting of the Court of Revision. An appeal form is attached.

In addition to the appeal to the Court of Revision, landowners not satisfied with Council's decision to proceed with the Big Marsh Drain No. 4 – New Maintenance Schedule can appeal to the Drainage Tribunal under section 48 (1) of the Drainage Act. The form entitled "Notice of Appeal to Tribunal by Owner of Land or Public Utility Re: Engineer's Report" is attached. All notices of appeal to the Drainage Tribunal shall be given in writing to Janice Hensel, CAO/Clerk of the Township of Pelee by April 30, 2021.

Purpose (Information/Action): To provide landowners the ability to appeal their assessment for

the Big Marsh Drain No. 4 – New Maintenance Schedule.

Overview

On March 22, 2021, Council provisionally adopted the Big Marsh Drain No. 4 – New Maintenance Schedule by giving first and second reading to Bylaw 2021-06. The Court of Revision is the next step in the Drainage Act process.

The Court of Revision hears appeals on the property assessment for drainage works under the Drainage Act. There has been no appeals received by Pelee Office from the landowners assessed for this project.

Financial Impacts

The engineer has used the estimated value of the Big Marsh Drain No. 4 of \$7,500 in the creation of the new maintenance schedule. The following is a breakdown of cost:

Township Roads	\$1,530
Township Properties	\$790 + assessment from Block F & G
Privately Owned – Non Agricultural Lands	\$2,178
Privately Owned – Agricultural Lands	\$3,002
Total Estimated Cost	\$7,500

The Township estimated assessment of \$7,500.00 has been included in the 2020 Budget.
