AND WHEREAS access to education and the presence of a school in a community is an essential service and has a direct link to the quality of life in a community;

AND WHEREAS schools play a key role in improving services and quality of life in a community and are viewed as activity centres where children have access to education, health services, recreation and culture;

AND WHEREAS schools are an important factor in the retention and attraction of residents in a community and is essential in order to resolve labour shortages and allow economic development and growth in small rural municipalities;

AND WHEREAS demographics in many areas are currently shifting and changing quickly as we work on meeting needs of many Ontario residents during a housing crisis;

NOW THEREFORE BE IT RESOLVED that Council is requesting provincial government through the Minister of Education to extend the moratorium on most pupil accommodation reviews in order to allow municipalities, townships, neighborhoods or subdivisions the opportunity to prosper, develop and grow without being hindered by school closure because of current low enrollments that could quickly change.

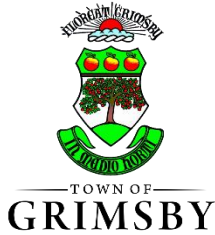





1. RECOMMENDATION:

It is recommended that:

1. The report from the Treasurer dated March 8, 2023 regarding Asset Management Compliancy **BE RECEIVED.**

2. BACKGROUND:

The Township of Pelee has been selected to participate in the AMP It Up 3.0 Program. The Municipal Finance Officers' Association of Ontario (MFOA), through its consultants and with funding provided by the Ministry of Infrastructure, will deliver this program. The Township of Pelee participated in AMP It Up 2.0 in 2019 with positive results.

The purpose of the program is to enable municipalities to understand the asset management plan (AMP) that they have and to obtain expert advice and guidance on their individual AMPs, specific to their situation. A maximum of 30 hours consulting assistance is funded through the program.

Asset management planning benefits the municipality through enhanced long-term financial planning, decision making, and meeting potential eligibility requirements for senior government funding. Under the Asset Management Planning for Municipal Infrastructure regulation (Ontario Regulation 588/17 as amended by Ontario Regulation 193/21 and as may be amended from time to time) under the Infrastructure for Jobs and Prosperity Act, 2015 (the "Regulation"), municipalities are required to develop and maintain an asset management plan that captures all municipal assets (assets that are included on a municipality's consolidated financial statements) by 2025.

The Township of Pelee staff will be working with PSD Citywide, our current asset management consultant to:

- Review the accuracy and quality of the inventory data and identify gaps on the asset management software
- Update the inventory data
- Review asset condition scores
- Identify additional levels of service metrics for core and non-core assets

Ontario Regulation 588/17 Schedule:

July 1, 2019: Finalize a strategic asset management policy that promotes best practices and links asset management planning with budgeting, operations, maintenance and other municipal planning activities. **COMPETED BY THE TOWNSHIP OF PELEE**

July 1, 2022: Finalize an asset management plan for core assets (roads, bridges and culverts, water, wastewater and stormwater management systems) that identifies current levels of service and the cost of maintaining those levels of service. **COMPLETED BY THE TOWNSHIP OF PELEE**

July 1, 2024: Required to have an approved asset management plan for all municipal infrastructure assets that identifies current levels of service and the cost of maintaining those levels of service.

July 1, 2025: Required to have an approved asset management plan for all municipal infrastructure assets that builds upon the requirements set out in 2024. This includes an identification of proposed levels of service, what activities will be required to meet proposed levels of service, and a strategy to fund these activities.
