Thank you for your email to the Honourable Caroline Mulroney, Minister of Transportation, regarding the Pelee Island ferry service. I appreciate the opportunity to respond on behalf of the ministry.

The Ministry of Transportation (MTO) and our agency and service provider, the Owen Sound Transportation Company (OSTC), are committed to providing a reliable and efficient ferry service.

MTO values our mutual engagement with the community, shared through the regular Pelee Island Transportation Services Advisory Committee (PITSAC) stakeholder meetings. The ongoing relationship and communication between the Township of Pelee and MTO is important. I understand your concerns about the channels of communication with MTO staff. We value this relationship and are committed to working with you.

The Jiimaan is currently out of service as it requires maintenance repairs before it can be placed into service again. The ministry is evaluating the future of the Jiimaan and will take into consideration the required upgrades as well as traveller and crew safety. The MV Pelee Islander continues to provide service while the ministry evaluates the future of the Jiimaan.

Agriculture and tourism are top of mind priorities when it comes to Pelee Island. Together with our service provider, the ministry continues to plan for a ferry service that supports the local economy and makes it easier for businesses to transport goods.

We look forward to collaborating with the Township and sharing recommendations on the next steps for this vital transportation service. Minister Mulroney,

The Township of Pelee is a small, rural and remote community with a year-round population of approximately 230 that swells to nearly 1,500 during the summer months. Pelee has many great features that make it a wonderful community to be a part of, however there are additional challenges that come with Pelee as well. One of the largest concerns presently, is the ferry service to Pelee Island.

When the Pelee Islander II was first put into service on April 6, 2019, the purpose of this vessel was to replace the nearly 60-year-old Pelee Islander. Further, it was to benefit the local economy by bringing more tourists to and from Pelee Island making it easier for businesses to move their goods between the island and mainland. However, in actuality the Pelee Islander II has not replaced the Pelee Islander, instead replacing the Jiimaan, resulting in limited improvements and benefits for the community since the introduction of the Pelee Islander II.

The current dry dock delay of the Pelee Islander II has only further highlighted the need for a two-vessel strategy and plan to be developed to replace the Pelee Islander – now a 63-year-old vessel. As a replacement vessel has yet to come to fruition, the community is currently relying on this 63-year-old vessel for all of the island's transportation needs through the dry dock delay. The Pelee Islander's size and capacity limitations, make it challenging to successfully service the island's needs, negatively affecting many individuals and businesses alike – while impacting two of the island's largest sectors of agriculture and tourism.

The Township of Pelee and its community needs commitment from the Ministry of Transportation that a replacement vessel with the required capacity – to benefit the local economy by bringing more tourists and making it easier for businesses to move their goods – is being planned for. Additionally, Pelee needs assurance that we will be included in this planning process moving forward.

The Township of Pelee has good working relationships with both Owen Sound Transportation Company and MTO. However, the cumbersome channels of communication that MTO staff must navigate are continually eroding the good working relationship with ground level staff, and affecting the public trust. Therefore, we are requesting a more open channel of communication with focused solutions and equity.

We look forward to a two-vessel strategy for Pelee Island, and continuing our working relationship with MTO.

The Town of Essex Council hereby appeals to the province of Ontario to acknowledge the challenges faced by our local emergency response system and take decisive action to resolve the gaps in our healthcare. While we recognize that our situation is not unique, we believe that it is essential to draw attention to our persistent Code Red and Code Black conditions, which are primarily caused by an insufficient number of hospitals beds, medical personnel, and resources.

Windsor and Essex County residents ought to have confidence that when they dial 911 it will elicit a prompt ambulance response for emergency situations. Local healthcare providers are engaging various initiatives such as a paramedic offload program, offload to the waiting room for assessment and triage of less severe medical matters, diversion to another hospital for low acuity cases, and the Essex-Windsor EMS paramedic patient navigator to monitor and manage dispatch. Nevertheless, these initiatives alone have been unable to curb the escalation of Code Red and Code Black frequency, signifying few or no ambulances available for emergencies.

In the year 2021, Windsor-Essex experienced a cumulative of 3253 minutes in Code Red and 791 minutes in Code Black. In 2022, the period subjected to Code Red increased significantly to 8086 minutes, whereas Code Black saw 2257 minutes. In March 2023, just three months into the year, the community has clocked 864 Code Red minutes already plus another 2257 Code Black minutes.

We implore the authorities to apply an immediate and comprehensive review of our hospital offload delays and staffing crisis in our front line. Ambulance offload processes and hospital volumes are merely two contributing factors, if nothing tangible is done, local families risk experiencing catastrophic consequences. Our former Warden, McNamara, declared an emergency on ambulance unavailability in October 2022 linked to hospital admission delays; to date, this emergency situation still holds with no decrease in Code Reds and Code Blacks.

We require a holistic solution to address our hospital deficiencies and healthcare shortcomings on an underlying basis. In addition, the Town of Essex Council request that the province of Ontario conduct a review of projected population growth and aging in Windsor – Essex and increase health care capacity to match our present and future needs.

1. **RECOMMENDATION:**

It is recommended that:

1. The report from the Drainage Superintendent dated June 22, 2023 regarding the request for Centre Dyke Road – Road Widening Review **BE RECEIVED as information.**

2. <u>BACKGROUND</u>:

At the May 23, 2023 Council Meeting, Council approved funding to complete bank repairs along Centre Dyke Road and Big Marsh Drain No. 1. In addition to the funding, Council requested Administration to report back on the Centre Dyke Road Widening and Grant Funding.

3. <u>DISCUSSION</u>:

In review of the Council agendas, minutes and information provided from Landmark Engineers, the following is the information on the Centre Dyke Road, Bank Failure and Repairs:

- April 16, 2007 Report prepared by Landmark Engineers Inc. provided findings of the site inspection of the failures along West Shore, South Shore, East Shore, Centre Dyke and West Pump Roads. This is the first report to Pelee Council that provided consideration for shifting the roads away from the Canals.
- April 30, 2007 Administration provides the report from Landmark Engineers on the bank failures to Pelee Council for consideration. Council approved the following resolution:

"Be it resolved that the Council of the Township of Pelee approves that a request for tender be put out for the following areas:

- o West Pump
- o Harris Garno Exit
- o Centre Dyke Road (Across from Airport)
- o corner of South Shore Road"
- June 18, 2012 Landmark Engineers provides a report on the Centre Dyke Road and West Pump Road relocation feasibility assessment proposal. Council passed the following resolution:

"Resolution 2012-124 – Resolved that the Council of Township of Pelee hereby agree to accept the report of Dan Krutch regarding the Centre Dyke/West Pump Feasibility Study and instructed the CAO to inquire if this could be put off until next year."

In review of the following agenda and minutes from 2013, there were no further actions taken by Administration or Council in 2013.

- 2018 Township Administration submitted a grant application under the Ontario Community Infrastructure Funding (OCIF). The proposed project included the following works:
 - o Shifting Centre Dyke Road 1-1.5 lanes away from Big Marsh Canal
 - o Re-shaping and grading the banks to 2 to 1 including Rip-Rap toe buttress
 - o Grading Shoulders
 - o Replacement of the Parson Roads Bridge at Centre Dyke Road

The total cost of the proposed project was \$3,219,756, which would cost approximately \$3,800,000.

Since 2018, there has been no further action from Administration on this project until the recent major bank failures along Centre Dyke Road.

The bank repairs that are being completed along Centre Dyke Road will not be lost work as the original proposal bank repairs included rip-rap at the toe of the bank.

The recommendation is to complete bank repairs on an annual basis to continue maintaining the banks and make the road safe for the travelling public. If in the future, the Township is successful in obtaining grant funding, then widening Centre Dyke Road and bank repairs can be accelerated. Council could consider preparing a Request for Proposal (RFP) for engineering and design for the Centre Dyke Road Widening and Big Marsh Drain No. 1 Bank Repairs. This would ensure that engineering has been completed and the project would be shovel ready when grant programs are announced and will assist administration is preparing grant applications. In 2018, the engineering cost provided in the grant application was \$499,460.

This work does not include any bank issues with the other 5 roads that are impacted by large canals. There is approximately 11.8 km of roads with canals adjacent in the Big Marsh Watershed and 2.1 km in the Curry Marsh Watershed.

By-Law 2022 - 54

"Emergency Response Plan"

A By-law to adopt an Emergency Response Plan under the *Emergency Management and Civil Protection Act* (Amended B/L 2023-43 June 27, 2023)

WHEREAS under the *Emergency Management and Civil Protection Act*, R.S.O. 1990, c. E.9 and (the "Act") Ontario Regulation 380/04 (the "Reg") every municipality in the Province of Ontario is required to:

- Develop and implement an emergency management program, which shall consist of:
 - o an emergency plan;
 - o training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
 - o public education on risks to public safety and on public preparedness for emergencies; and
 - o any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario;
- Designate an employee of the municipality or a member of the council as its emergency management program coordinator;
- Establish an emergency management program committee;
- Establish an emergency control group;
- Establish an emergency operations centre to be used by the municipal emergency control group in an emergency; and
- Designate an employee of the municipality as its emergency information officer;

AND WHEREAS it is prudent that the emergency management program developed under the Act be in accordance with international best practices, including the five core components of emergency management; prevention, mitigation, preparedness, response and recovery;

AND WHEREAS the purpose of such a program is to help protect public safety, public health, the environment, critical infrastructure and property during an emergency and to promote economic stability and a disaster resilient community;

NOW THEREFORE the Council of the Corporation of the Township of Pelee hereby enacts as follows:

Emergency Response Plan

1. The Emergency Response Plan, which has been developed in accordance with the requirements of the Act and Reg and international best practices, and which is attached hereto as Schedule A is hereby adopted (the "Plan").

- 2. The Plan shall be reviewed annually by the CEMC and the Emergency Management Program Committee. The CEMC is authorized to make such administrative changes to the Plan as appropriate to keep the Plan current, such as personnel, organizational and contact information updates. Any significant revision to the body of the Plan shall be presented to Council for approval.
 - (When an emergency exists but has not yet been declared to exist, employees and the Emergency Control Group may take such action under the Plan as may be required to protect property and the health, safety and welfare of the inhabitants of King's Landing.)
- 3. When an emergency exists but has not yet been declared to exist, employees and the Emergency Control Group may take such action under the Plan as may be required to protect property and the health, safety and welfare of the inhabitants of the Township of Pelee. (Amended B/L 2023-43, June 27th, 2023)

Administration

- 1. The Plan shall be made available to the public for inspection and copying at the Municipal Office, during regular business hours and on pelee.org.
- 2. The Plan, or any amendments to the Plan, shall be submitted to the Office of the Fire Marshal and Emergency Management as identified in the Act.
- 3. By-laws 1615 is hereby repealed.

Subject: Small Craft Harbours' Facility – Scudder Marina

1. **RECOMMENDATION:**

It is recommended that:

- 1. The report from the Township Administrator & Clerk dated June 23, 2023 regarding the Small Craft Harbours' Facility **BE RECEIVED** as information; and
- 2. The Mayor and Clerk **BE AUTHORIZED** to execute an agreement with Fisheries and Oceans Canada for the Small Craft Harbours' facility.

2. BACKGROUND:

The Township of Pelee has an ongoing lease agreement with Fisheries and Oceans Canada for the Small Craft Harbours' facility, known as the Scudder Marina docks water lot. This agreement is renewed every five (5) years.

At the Regular Meeting of Council on February 14th, 2023, Council passed resolution 2023 – 36, to direct Administration to inquire into the possibility of a divestiture with Fisheries and Oceans Canada (DFO) for the water lot known as the area of the Scudder Marina docks.

3. <u>DISCUSSION</u>:

Administration has inquired into the possibility of a divestiture with DFO, however DFO has not responded to this inquiry as of yet.

Therefore, Administration recommends approving the new lease agreement as written until further discussions are had with DFO regarding the possibility of a divestiture, as the previous lease agreement expired December 2022. Administration will continue to engage DFO regarding a divestiture of the Scudder Marina docks.

4. **FINANCIAL MATTERS**:

Rental rate for the Small Craft Harbours' facility (Scudder Marina docks water lot), to remain at a rate of \$500 per annum or 20% of gross revenue (whichever is the greater), as outlined in pervious agreements.

6. <u>CONCLUSION</u>:

It is recommended that the Council authorize the Mayor and Clerk to execute the lease agreement with Fisheries and Oceans Canada for the Small Craft Harbours' facility in order to continue to utilize the facilities. Administration will continue to engage DFO regarding the possibility of pursuing a divestiture.

BY-LAW 2023 – 43

By-Law to amend By-Law 2022 - 54

WHEREAS under the *Emergency Management and Civil Protection Act*, R.S.O. 1990, c. E.9 and (the "Act") Ontario Regulation 380/04 (the "Reg") every municipality in the Province of Ontario is required to:

- Develop and implement an emergency management program, which shall consist of:
 - o an emergency plan;
 - training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
 - o public education on risks to public safety and on public preparedness for emergencies; and
 - o any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario;
- Designate an employee of the municipality or a member of the council as its emergency management program coordinator;
- Establish an emergency management program committee;
- Establish an emergency control group;
- Establish an emergency operations centre to be used by the municipal emergency control group in an emergency; and
- Designate an employee of the municipality as its emergency information officer;

AND WHEREAS it is prudent that the emergency management program developed under the Act be in accordance with international best practices, including the five core components of emergency management; prevention, mitigation, preparedness, response and recovery;

AND WHEREAS the purpose of such a program is to help protect public safety, public health, the environment, critical infrastructure and property during an emergency and to promote economic stability and a disaster resilient community;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF PELEE HEREBY ENACTS AS FOLLOWS:

1. That Section 3 under "Emergency Response Plan" of By-Law 2022-54 is hereby deleted, and the following is substituted for it;

"When an emergency exists but has not yet been declared to exist, employees and the Emergency Control Group may take such action under the Plan as may be required to protect property and the health, safety and welfare of the inhabitants of the Township of Pelee."

2. That all other provisions of By-Law 2022-54 remain in full force and effect.

"Lottery Licensing"

Being a by-law to appoint Lottery Licensing Officers and provide for the licensing of lotteries in the Township of Pelee.

WHEREAS lottery licensing is governed in accordance with the *Criminal Code* (Canada), the *Gaming Control Act*, 1992, S.O. 1992, c. 24, and Order-in-Council 1413-08;

WHEREAS Order-in-Council 1413-08 authorizes municipal councils to issue a license authorizing eligible charitable and religious organizations to conduct and manage the types of lottery schemes as may be specified by the Registrar and approved by the Minister;

AND WHEREAS the Council of the Corporation of the Township of Pelee deems it expedient to license said lottery schemes;

NOW THEREFORE, the Council of The Corporation of the Township of Pelee enacts as follows:

- 1. **THAT** all lottery schemes as specified by the Registrar of Alcohol and Gaming are hereinafter to be licensed and conducted in accordance with any and all requirements of the Alcohol and Gaming Commission of Ontario.
- 2. THAT the Clerk and Treasurer shall be appointed Lottery Licensing Officers.
- 3. THAT this by-law shall come into force upon passing.
- 4. **AND THAT** By-law No. 2018 38 is hereby repealed.
