

# The Corporation of the Township of Pelee

## By-law No. 1549

Being a by-law to appoint committees and it's members.

**WHEREAS** a Council of a Municipality may by by-law constitute and appoint a committee for the municipality composed of such persons, not fewer than three, as the Council considers advisable;

**AND WHEREAS** according to the Ontario Planning Act, R.S.O. 1990, c/P.13, S.44 (1). the Council of a municipality may by by-law constitute and appoint a committee of adjustment for the municipality composed of such persons, not fewer than three, as the Council considers advisable;

**AND WHEREAS** the members of the committees who are not members of Council shall hold office for the term of the Council that appointed them and the members of the committee who are members of Council shall be appointed annually; members of the committee shall hold office until their successors are appointed, and are eligible for reappointment, and where the committee is composed of three members, tow members constitute a quorum and where the committee is composed of more than three members, three members constitute a quorum;

**AND WHEREAS** as soon as practical the committee shall make a report to the Council summarizing the events and findings of the Committee;

**NOW THEREFORE**, the Council of the Corporation of the Township of Pelee (hereinafter called the Corporation) **HEREBY ENACTS AS FOLLOWS:**

**THAT** the following persons are appointed as member to the various committees as described below:
