

The Corporation of the Township of Pelee

By-law 1607

Being a by-law to provide for the fixing of rates or charges for
supplying water to consumers in the West Shore Road Water
System

WHEREAS the Council of the Township of Pelee, has constructed the West Shore Road Water System;

AND WHEREAS the operational and maintenance costs of the water system must be paid by the users of the system;

AND WHEREAS the Public Utilities Act provides the authority to fix the rates for water used;

NOW THEREFORE The Council of the Corporation of the Township of Pelee **ENACTS AS FOLLOWS:**

THAT all consumers on the West Shore Road Water System, list of users attached as 'Schedule A" shall pay a metered rate of \$3.00 per one hundred (100) gallons of water consumed;

AND THAT a minimum rate of \$330.00 per annum be charged to consumers using less than 3300 gallons per annum;

AND THAT an interim payment will be estimated in May for a June 1st payment, based on 50% of previous year's consumption;

AND THAT a final payment will be sent in December for a December 31st payment, based on meter readings for that year, less the interim estimate paid;

AND THAT all charges shall be paid into the office of the Treasurer or the Collector of Taxes of the Township of Pelee;

AND THAT a penalty of one and a quarter percent (1.25%) on the first day of each calendar month thereafter in which default continues shall be imposed for non payment of water rates;

AND THAT the Treasurer and the Collector may accept part payment from time to time on account of any instalments, provided that acceptance of such payments shall not effect the collections of the percentage charges imposed above;

AND THAT this By-law shall come into force and take effect on the 1st day of January 2004 and its short title shall be "2004 West Shore Water Rates".
