

# **The Corporation of the Township of Pelee**

## **By-law No. 1639**

**Being a by-law to designate the  
date on which a reduced load  
period shall start and shall end.**

**WHEREAS** Section 122(7) of the Highway Traffic Act, R.S.O. 2001, Chapter H.8, as amended provides that;

The Municipal Corporation of the Township of Pelee or other authority having jurisdiction over a highway may by by-law designate the date on which a reduced load period shall start or end and the highway or portion thereof under its jurisdiction to which the designation applies;


**AND WHEREAS** the reduced load period is deemed necessary for the protection of certain highways in the Corporation of the Township of Pelee.


**NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE  
TOWNSHIP OF PELEE HEREBY ENACTS AS FOLLOWS:**

- 1. The provisions of subsections 1, 2, 3 and 4 of Section 122 of the Highway Traffic Act apply to the highways named in Schedule "A" attached and forming part of this By-law during the period from the 1<sup>st</sup> day of March to the 1<sup>st</sup> day of June inclusive in each and every year or at any other time as may be deemed necessary.**
- 2. Any person violating the provisions of this By-law shall be subject to the penalties provided in Section 125 of the Highway Traffic Act and all such penalties shall be recoverable under the Provincial Offences Act.**
- 3. This By-law shall not become effective until appropriate signs have been erected in accordance with the regulations under the Highway Traffic Act.**
