

The Corporation of the Township of Pelee

By-Law No. 1695

Being a By-Law to Issue Licenses and Charge Fees to
Hunt Pheasants in the Township of Pelee

WHEREAS pursuant to the provisions of the Game and Fish Act, R.S.O. 1980, and the regulations made there under, the Corporation of the Township of Pelee has authority to issue and charge fees for licenses to hunt pheasants;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE
TOWNSHIP OF PELEE ENACTS AS FOLLOWS:

THAT for the purpose of this by-law and the issuing of licenses

- “Resident” includes (1) any person who has been in continuous residence in the Township of Pelee for at least six months in the twelve months preceding the 30th day of October in the current year, and (2) that any person must submit a valid driver’s license indicating a residence address of Pelee Island;
- “Non-Resident” includes any person who has not been in continuous residence in the Township of Pelee for at least six months preceding the 30th day of October in the current year;

AND THAT no person shall hunt pheasants on Pelee Island until a license for the purpose has been obtained from the Township of Pelee;

AND THAT licenses to hunt under the authority of this by-law shall be in a form approved by the Ministry of Natural Resources.

AND THAT the Clerk of the Township of Pelee or any other person or persons appointed by the Council shall issue and sell licenses as follows:

AND THAT for the purpose of this by-law, all Township licenses issued in the County of Essex are non-reciprocal for the hunting of pheasants and rabbits during the open seasons within the Township of Pelee;

AND THAT this by-law shall come into effect on the date of passage subject to the approval of the Ministry of Natural Resources;


AND THAT By-law 1598 and any other heretofore passed pursuant to the provisions of the Game and Fish Act, R.S.O. 1980 are hereby repealed.

AND THAT this By-law shall come into force and take effect on the 7th day of July, 2008 and the short title of this By-law is "Pheasant Hunt Licensing".
